# PRESIDENT'S MESSAGE November 2009

ne of the tenets of the AAEM mission statement is to "provide affordable, high-quality continuing medical education in emergency medicine for its members." And, CAL-AAEM has delivered.

Dr. Joanne Williams, our CAL/AAEM Education Chair, has single-handedly developed and chaired several national preconference workshops at the AAEM Scientific Assembly over the past few years. Our first CME program, "Pain Management & End-Of-Life Care in the ED," was a response to AB487 bill that became the Business & Professions Code Section 2190.5. In accordance with this Code, all physicians (except radiologists and pathologists) needed to document 12 CME hours in pain management and endof-life care by December 31, 2006. "Trauma Resuscitation for the Community Doc" was our 2nd CME course in San Antonio, TX. This 1 day-course covered management of trauma and multi-system injury as well as risk management in trauma for the community emergency physician, with special focus on the pediatric, pregnant, and geriatric trauma patient. And, last year in Phoenix, AZ, "Children Are Not Little Adults! - Pediatric Emergencies" was extremely well attended and received such rave reviews that we're doing it again at the AAEM Scientific Assembly in Las Vegas this year on Feb 14, 2009!

The Lifelong Learning Self-Assessment is still a requirement. As a CAL/AAEM
