Definitions

On topic - must tell a story about COVID-19 experiences; can be personal, anecdotal, opinion; may not directly mention the word "COVID" or "pandemic" but talks about protocols, impact on quality of life

Off topic - does not mention COVID-19 at all; could mention COVID-19 (e.g. I got tested) but rest of narrative goes off in a completely different direction
